

Counsel had an oral argument in the case of Stanley Wise v. State of South Carolina with this Court on June 4, 2014. Counsel filed petition for writ of certiorari and accompanying appendix in the case of Dexter Palmer v. State of South Carolina with the Supreme Court on June 2, 2014.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




