




PERSONALLY appeared before me, Jarrett S. Calder, Esq., who being duly sworn states as follows:



5. That I request that the Court of Appeals grant my above-referenced request.

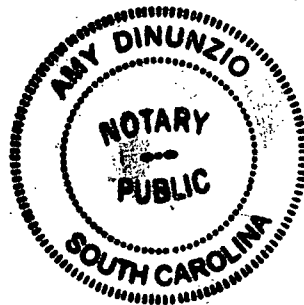

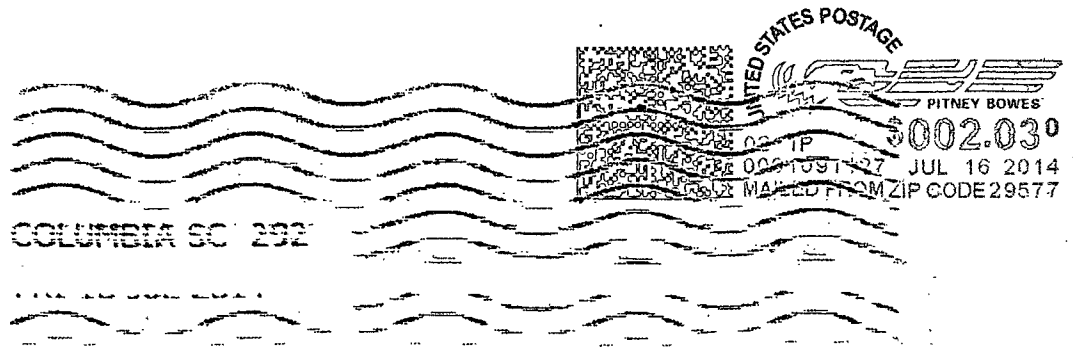
