
Dear Ms. Allen:

I appreciate your staff's assistance in handling my recent request for an extension until July 31 to file Appellants' Initial Reply Brief. A matter has come up that counsel for all parties thought should be summarized for you.

As was discussed earlier in the year, the court reporter at the trial did not transcribe portions of deposition testimony read into the record. The court granted the parties motion to allow the record to be corrected by including the transcript of those portions of deposition testimony. The Respondents Brief mistakenly includes portions of a deposition that was not read into the record. They have informed me that they will need to move to amend their Initial Brief and their Designation of Matter to be Included in the Record on Appeal. For this reason, our Initial Reply Brief would not be due until 10 days after receipt of the amended brief. This will happen quickly I believe and there should not be much delay in the final filings in the case.
