3. For this reason, the Appellant would request permission to serve and file a Supplemental Record on Appeal to include pages 491 through 525 of the trial transcript.


The selected pages have already been redacted and are ready for printing and binding.

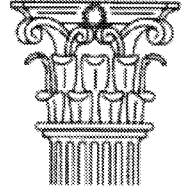

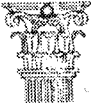
