

State in the Court of Appeals on June 10, 2014. Counsel argued in the case of Mark R. Bolte v. State in the Court of Appeals on June 5, 2014. Counsel argued in the case of Steve Bagwell v. State in the Court of Appeals on June 3, 2014. Counsel filed the initial brief of appellant in the case of State v. Jeffrey Thomas Brown in the Court of Appeals on June 2, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Steven McFarland v. State in the Supreme Court on May 28, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Donnie Mack Hagins v. State in the Supreme Court on May 28, 2014.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


