
Dear Ms. Kitchings:

Enclosed is a copy letter from Mr. Evans, Assistant General Counsel, SCDPPPS, dated July 9, 2014, regarding his findings that I was on probation for the offense of murder. His findings show that the department's records do not indicate nothing that I have been on probation. In addition, the department should have an archives location to retrieve such records. However, please be advise that I have never ever been on probation for the offense of murder, in fact, I was a law enforcement officer between 1984 through August 23rd, 1990. The State of South Carolina nor North Carolina would never hire anyone on probation for the offense of murder into law enforcement. In addition, the Department of Probation and Parole for the State of South Carolina was going to hire me as a probation officer in 1986, but I declined the position because the department indicated that I had to relocate to another county within the state.

The Respondent open the door to this matter, and I desire very much to have this matter resolve and ask that the Respondent recant that I was on probation for the offense of murder at the time of the commitment offense before this Court.

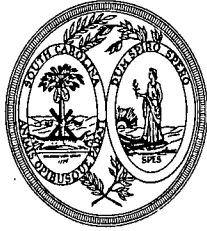



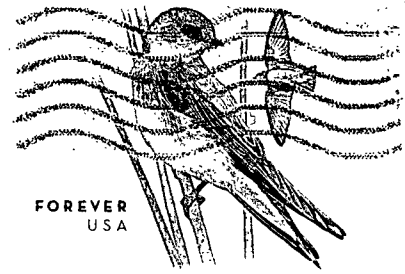
