Dear Ms. Kitchings:

We represent the Respondent, Business Loan Center, LLC, in the above-referenced appeal. Our Initial Brief is currently scheduled for filing on July 25, 2014. The underlying foreclosure action is in the process of being dismissed and a Stipulation of Dismissal has been circulated to counsel for Subham Hospitality, Inc. Since Appellant's consent to the Stipulation of Dismissal has not been received, the same has not been filed with the Circuit Court. Once the Dismissal and Cancellation of the Lis Pendens is filed in the Circuit Court, the Appellant's appeal will be moot.

Under the circumstances it does not appear to be in anyone's interest, including our client's, for us to prepare and file an Initial Brief. Respondents therefore request an extension for filing its Initial Brief to allow time for the proper dismissal papers to be executed by all parties and filed with the lower court. 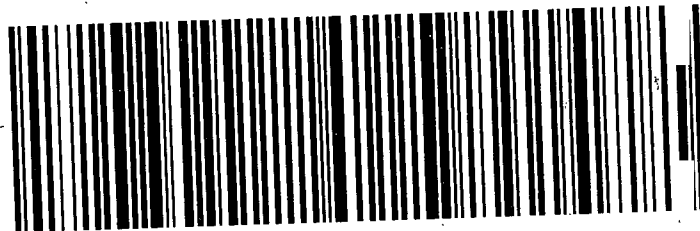
