
Amended Notice of and Motion to be Relieved as Appellant's Counsel

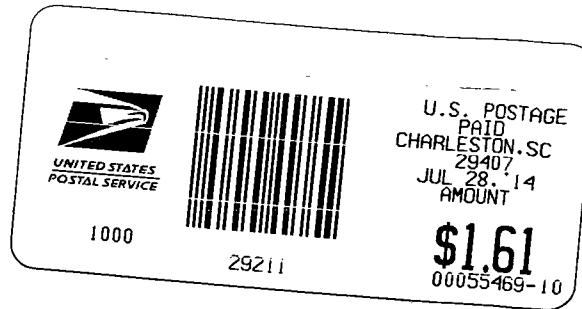
