ORDER INFORMATION

This matter comes before the Court pursuant to the Defendants/Appellants' appeal of the Decision and Order of the Appellate Panel of the South Carolina Workers' Compensation Commission. The findings of the Workers' Compensation Commission are reviewed by the Circuit Court under the substantial evidence standard of review. This Court has reviewed the Decision Order of the Workers' Compensation Appellate Panel, the submissions of the parties, the applicable case law, and the arguments of counsel. Having considered the same, this Court **AFFIRMS** the ruling of the Workers' Compensation Appellate Panel. The Order of the Workers' Compensation Commission is thorough and exhaustive, and there is substantial, both in its technical and colloquial sense, evidence to support the Appellate Panel's findings. Furthermore, those findings are in keeping with the South Carolina Court of Appeals' decision in *Reed-Richards v. Clemson University*, 371 S.C. 304, 638 S.E.2d 77 (2006).
