Enclosed please find a copy of the Order of the South Carolina Supreme Court dismissing the petition for certiorari I filed on behalf of my client. The case is settled.


Accordingly, I would appreciate it very much your sending the remittitur down to the circuit court, so that Mr. Booth and I can file the appropriate stipulation of dismissal.



Based on the joint motion filed by the petitioner and respondent, the petition for a writ of certiorari is hereby dismissed.



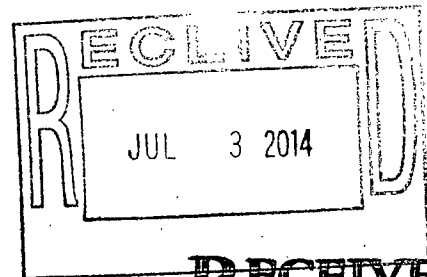
