RESPONDENT SOUTH CAROLINA COASTAL CONSERVATION LEAGUE'S
MOTION TO CORRECT THE INITIAL BRIEF AND DESIGNATION OF MATTER


Respondent South Carolina Coast Conservation League ("Respondent") moves, with the consent of the Appellants North Pleasant, LLC and Vanguard Development Group, LLC, ("Appellants") to file an amended Initial Brief of Respondent and Designation of Matter to be included in the Record on Appeal. Respondent's initial brief mistakenly included references to deposition testimony of a witness, Daniel Fogarty, whose deposition testimony was not actually admitted during the trial of this case.

This Court previously granted Appellants' Consent Motion to Correct the Record of the Trial to include the parties' mutual designations of portions of four depositions that were read into evidence. Respondent mistakenly overlooked that Daniel Fogarty's deposition testimony

was not one of the four depositions read into evidence at trial and mistakenly included four references (pages 7, 11, and 24) to his deposition testimony in its initial brief.

The parties agree that the most efficient and prudent way to resolve this problem is to grant Respondent leave to file the attached amended Initial Brief, which does not include the sentences or citations referring to Daniel Fogarty's deposition testimony, and grant Respondent leave to file the attached amended Designation of Matter to be Included in the Record on Appeal, which does not include references to Daniel Fogarty's deposition testimony.


