This is concerning the Extension Motion to Request Transcripts out of Time. On July 1st, 2014, I spoke with Mrs. Rita Reagal concerning the Request for a Transcript. Mrs. Reagal advised me that she was not able to release the Transcript, so therefore I will have to speak with Mrs. Eugenia Hollmon in the Judicial Department.
