
The motion is hereby dismissed.

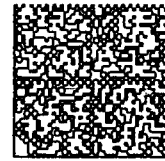
