## ORDER

Respondent has filed a motion to strike and a request to stay the appellate deadlines until resolution of the motion to strike. After careful consideration of the parties' filings, Respondent's motion to strike is granted. *See* Rule 211(b), SCACR (stating the final brief must be *identical* to the initial briefs with the exception of adding citations to the record on appeal and correcting typographical errors and misspellings); Rule 210, SCACR (stating the record on appeal must include a proper index, only include matters designated by either party, be numbered consecutively beginning with the index, and include a certificate of counsel certifying the record contains "all material proposed to be included by any of the parties and not any other material."). Appellant shall serve and file an amended record on appeal and final brief within twenty days. Respondent's final brief shall be served and filed twenty days after service of the record.
