

AFFIDAVIT

Personally appear before me, a magistrate of this county one, Det. Leslie Ambrose, who first being duly sworn deposed and says that, Christopher Terell Gilyard, did within this county and state on the 11 July 2012 violate the criminal laws of the State of South Carolina in the following particular:

DESCRIPTION OF OFFENSE

Criminal Sexual Conduct with a Minor - 2nd degree  
16-3-655(B)

The affiant states there is probable cause to believe that the defendant named did commit the crime set forth and that such probable cause is based on the following facts:

On 11 July 2012 between 1600 and 1630 hours, while at 1209-B Sam Rittenberg Blvd. (Shear Beauty), in the city and county of Charleston, the defendant Christopher Terell Gilyard did knowingly, willingly, and unlawfully violate CSC with a Minor - 2nd degree. The defendant worked as a barber for the victim's mother. The victim is a 14 y/o B/F. While the defendant was in the shop with the victim (only other person present was a 3 y/o who was asleep), the defendant touched the victim's breasts over her shirt. He then pushed the victim down to the floor on her back, pulled down her pants and underwear, pulled down his pants and underwear, and forcibly had vaginal sexual intercourse with her. The victim advised that she tried to push him off of her, but he was too heavy. She said she tried to scream, but the defendant told her, "Shut the fuck up" and "You better not tell anyone or I'll kill you, I swear to God." This lasted approx ten minutes. The victim and her mother know the defendant by name and sight. The above statements are true and believable based on the statements of the victim and the investigation of Det. Ambrose.
