





ORDER

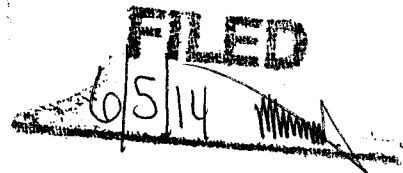
