

Appellant was sentenced to twelve (12) years suspended to six (6) years imprisonment and four (4) years probation by the Honorable Eugene C. Griffith, Jr., on August 6, 2014. Defendant was tried on the same offense on July 7 through July 11, 2014, resulting in a mistrial/dead-locked jury.



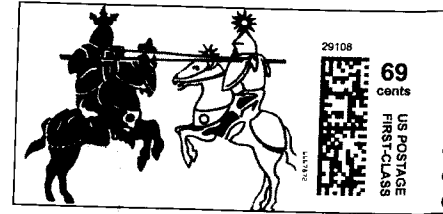
