


**STIPULATION OF DISMISSAL ONLY AS TO RESPONDENT CHARLA



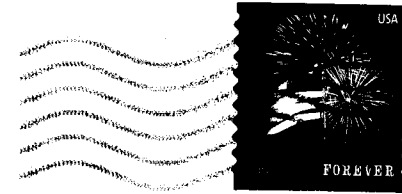
