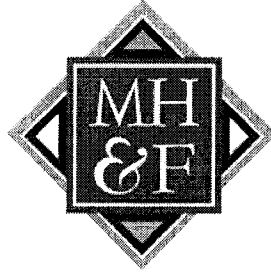



Dear Ms. Pilgrim,

I have received your letter dated May 6th, wherein you request the Transcript of Record in the case of Jackson vs. Edgefield Medical Clinic. Upon review of my notes I estimate the transcript will be approximately 600 pages long for an estimated cost of \$1,960, which includes postage and handling. An electronic copy can also be furnished with any official transcript order for an additional \$35, which would total \$1,995.

If the transcript is smaller than estimated, I will certainly refund your money. Likewise, if it is larger than my estimation, I will either call or write you to let you know of the balance owed.

It is necessary that I receive payment before typing the transcript in the form of a law firm check, cashier's check or money order made payable to Bethanie Patterson. I cannot accept a personal check from your client. Upon receipt of the funds I will place your transcript in line for production. By statute, I am allowed 60 days to complete the transcript. If a longer period is needed, I will request an extension and you will be informed by Court Administration, however, I do not believe that will be necessary, nor do I anticipate that it will take the full 60 days to complete the transcript.

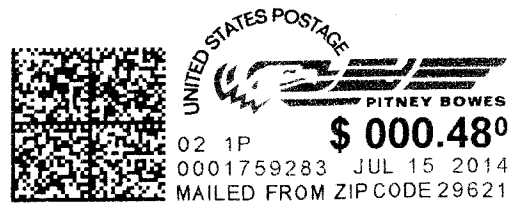
