
COME NOW Respondents and submit this Return to Petitioner's Petition for Rehearing pursuant to Rule 240, SCACR.

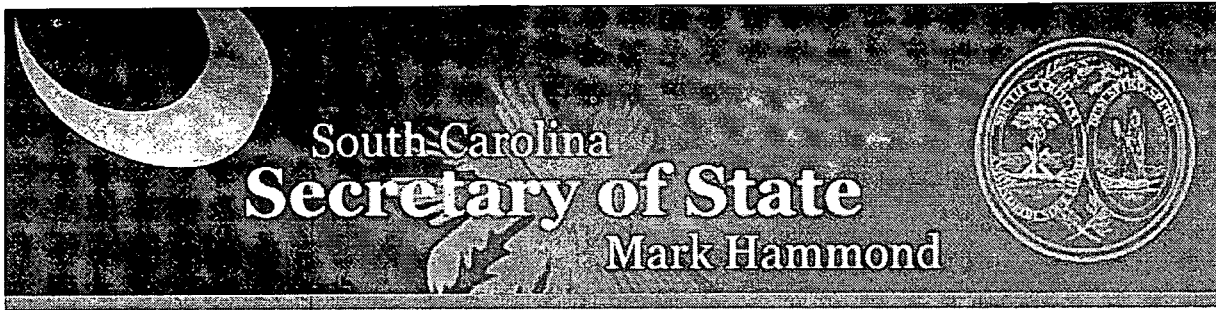
WHEREFORE, Respondents respectfully request that this Court deny Petitioner's Petition for Rehearing.

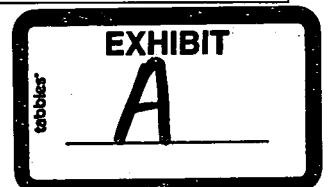




