ORDER

Respondents have filed a motion to require Appellant to amend the record on appeal. After careful consideration, Respondents motion is granted and Appellant will file an amended record on appeal within thirty days of this order. The amended record on appeal shall include the following: 1. The complete transcript from the February 7, 2013 motion hearing; 2. Plaintiff's response to Co-Defendants Scott Franklin and Brian Buck' motion to deny relief; 3. The names and addresses of Respondents' counsel on the cover page; and 4. Sequential page numbers. Further, Appellant will redact any personal data identifiers and sensitive

information pursuant to The Supreme Court of South Carolina's August 13, 2007 order. *See In Re: Interim Guidance Regarding Personal Data Identifiers & Other Sensitive Info.in Appellate Court Filings*, S.C.Sup.Ct. Order dated August 13, 2007. Moreover, the amended record on appeal shall not include Appellant's opening statement or a statement of the case. *See* Rule 210(c), SCACR (noting the record on appeal "shall not . . . include matter which was not presented to the lower court or tribunal"). Finally, Appellant is reminded future failures to comply with the Appellate Court Rules may result in dismissal of this appeal. *See* Rule 260(a), SCACR (noting this Court may dismiss an appeal for failing to comply with the requirements of the Appellate Court Rules).
