My husband and I are seniors with very severe health problems. We have not been able to move forward with these legal problems because of our health problems. We can only do a little at a time because of our health problems.


We received a letter from the appeals court. They want to know when we are going to have the trial transcripts.



Ms. Green,

After getting in touch with Linda Moffitt, who was the court reporter for our trial, she informed us that you were the actual court reporter that prepared the transcript of our trial. We had filed for an appeal but have been very sick and have not been able to proceed with taking care of things. We are in the process of trying to find a new attorney to continue with this as our original attorney has been dismissed. We felt that we were misrepresented by him. For this reason, we are trying to take care of these things ourselves in the meantime. We are requesting that you prepare a copy of our transcript. I realize that there is a cost involved. Please let me know the cost of this and I will send the payment for the transcript to you. My daughter spoke with you at one point but the transcript had not been processed at that time. She thought that you were just helping Ms. Moffitt out with this and did not realize that you had taken this over. This is why we recently sent a letter to the original court reporter regarding this and not to you.

The South Carolina Court of Appeals is requiring me to provide proof to them by this Friday, June 13, that the transcript has been ordered. As you can see from the attached letter to Ms. Moffitt, we sent the letter to her three weeks ago. We just received the response from her in the mail yesterday telling us to get in touch with you for the copy of the transcript. Could you possibly send us a quick response to this letter back to my daughter's email that you have received the request yourself and note when we might expect to receive the copy? That way, we can forward your response to the SC Court of Appeals by the deadline of June 13 per their requirement. My daughter's work email is jane@tuckandhowell.com. 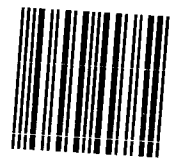
