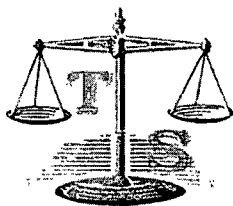

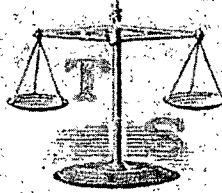

17 to you in the next two weeks.


