I AM THE ONLY ONE HERE THAT THE GUYS RESPECT BECAUSE THEY KNOWS THAT I AM IN HERE FOR A CRIME THAT I DIDN'T COMMIT. EVERYONE RESPECT ME BECAUSE I COULDN'T TALK AND WOULD'VE BEEN ON THE STREETS.

THE YOUNG GUYS THINK THAT THAT GANGSTER. THESE GUYS HAVE UNBELIEVABLE RESOURCES IN THE NEIGHBORHOOD AND POLICE DEPTS. THAT'S WHY ALOT OF PEOPLE OUT THERE ARE GETTING KILLED AND GETTING MISSING. THE COPS TELL ON THE GUYS THAT RAB ON OTHERS.

Madam back in 2000 + 2010 I filed 1983 civil complaint against
Red Team. Simon Bracey or Major Bracey. I didn't know that
his wife worked in the mailroom here. This man took my
legal box with all my transcripts of both trials, and all hearings
I had statements. Newly discovered evidence, that could
exonerate me. I filed it when I was broadriver car. Just
I file for the state to do a DNA test on the blood
that was in my cloths. I knew I did nothing to anyone

I wonder why would this guy order those people to take my legal box. These people at Evans shipped me here. They knew Ms. Simon Bizey was here. I filed my civil complaint. And stomp them in head and between there legs. It's said they don't have a voice. I am on a whisper for them. This is a witness his name is Joseph Eagle.
