REPLY TO RESPONDENT ON THE PETITION TO REINSTATE APPEAL



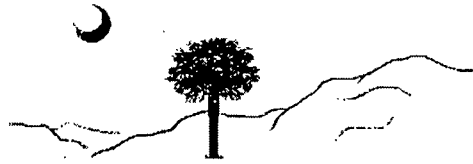
