My name is Low Ann Robinson and I am currently an inmate with SCDC, serving a 12 year sentence.

I filed a motion for reconsideration to no avail at the General Sessions level (Circuit's). I further filed an appeal with the State Supreme Court in which I received partial modification; but not in the form of sentence amending. Because of the partial change which substantiated my claims of abuse had not been taken into consideration even after validated by an expert witness. This oversight has possibly caused sentencing and/or charges to not be correct.

I've served 5 years and at this point I'm petitioning for reconciliation to be considered for Parole as soon as possible. 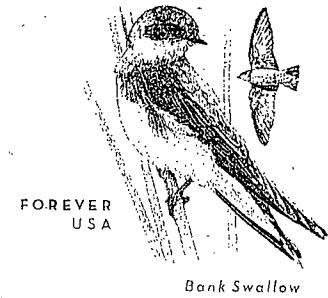

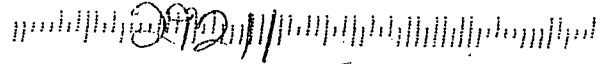
