

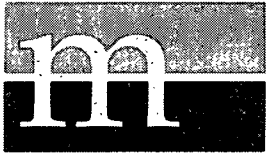
I appreciate your consideration of this request and ask that you hold the filing time in abeyance during the time in which this request is pending.

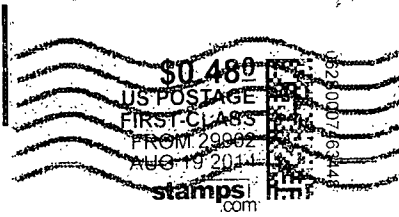
