

Counsel filed the petition for writ of certiorari and accompanying appendix to the Court of Appeals in the case of State v. Eric Wright with the Supreme Court on July 11, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Matthew Antwan Jackson with this Court on July 11, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Nathaniel McGee v. State of South Carolina with the Supreme Court on July 2, 2014. Counsel had an oral argument in the case of State v. Jomar Robinson with the Supreme Court on June 24, 2014.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


