




Gentlemen:

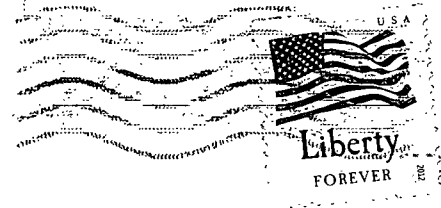
