


## ORDER

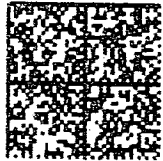

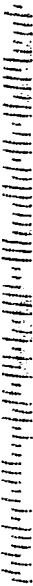

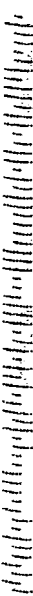
