RECORD ON APPEAL


Pursuant to Rule 224, SCACR, the undersigned counsel respectfully petitions this Court for leave to file copies of an Amended Record on Appeal in the above titled case. In support of this petition, counsel would submit the following information.

1. Appellant Raheem Jamar Bonham was convicted of possession of crack cocaine per jury trial held during the June 2013 term of the Lexington County General Sessions Court before Judge William P. Keesley. Appellant was sentenced to imprisonment for a period of one year.
2. Appellant appealed and an Anders Brief of Appellant and Record on Appeal were filed by the undersigned counsel with this Court on January 2, 2014. On August 14, 2014, this Court submitted an Order requesting that the case be re-briefed.

copies of the Amended Records on September 3, 2014, when the Brief of Appellant is due to be filed with this Court.




