MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Jabriel Singleton respectfully requests a **final thirty (30) day extension, until October 10, 2014**, in which to file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fifth request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter are due to be filed with the Court today. The Court has granted counsel four previous extensions. **Counsel for appellant intends to file the initial brief no later than September 19, 2014.**

2. Counsel for Jabriel Singleton respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. **The transcript in Mr. Singleton's case exceeds 1,100 pages.** Counsel has three oral arguments before this Court this week. Counsel has an oral argument in the case of State v. Anthony Jackson in this Court today. Tomorrow, counsel is arguing the case of State v. Antonio Glover. Yesterday, counsel had an oral argument in the case of State v. Christopher Paul Mahaffey.


3. Counsel is also working on State v. Ricky Blackwell, a direct appeal in a capital case, and the transcript is 4,751 pages. Counsel filed the brief of petitioner in the case of State v. Darren G. Scott with the Supreme Court on September 4, 2014. Counsel filed the return to the petition for writ of certiorari to the Court of Appeals in the case of State v. Julian De'Andre Battle with the Supreme Court on September 3, 2014. Counsel filed the return to the petition for writ of certiorari to the Court of Appeals in the case of State v. Kevin Tyrone Bennett with the Supreme Court on August 28, 2014. Counsel filed the record on appeal in the case of Michael D. Hall v. State of South Carolina which was granted, and expedited in the original jurisdiction of the Supreme Court, with the Supreme Court on August 27, 2014, as co-counsel. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Gerald Barrett with this Court on August 27, 2014. Counsel filed the designation of matter in the case of Michael D. Hall v. State of South Carolina with the Supreme Court on August 22, 2014, as co-counsel. Counsel filed the initial brief of appellant and designation of matter in the case of State v. William Donald Bolt with this Court on August 20, 2014. Counsel filed the brief of appellant and designation of matter in the case of State v. Talmadge Rowell with this Court on August 8, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. John Edwards Haynes with this Court on July 29, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Randall S. Tyler v. State of South Carolina with the Supreme Court on July 28, 2014. Counsel filed the brief of appellant and designation of matter in the case of State v. Benjamin William Rhodes with this Court on July 17, 2014. Counsel filed the petition for rehearing in the case of State v. Jason Alan Johnson with the Court of Appeals on July 14, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Brandon S. McDevitt v. State of South Carolina with the Supreme Court on July 14, 2014. Counsel filed the brief of petitioner in the case of Charles Ray Dean v. State of South Carolina with this Court on July 11, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix to the Court of Appeals in the case of State v. Eric Wright with the Supreme Court on July 11, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Matthew Antwan Jackson with this Court on July 11, 2014.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request shown by signature below.




