1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today.



Counsel filed the initial brief of appellant and designation of matter in the case of State v. Sammy Scarborough with the Court of Appeals on August 27, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Kelvin Mays v. State with this Court on August 21, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jesse Ray Lane v. State with this Court on August 18, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Deshawn Powell in the Court of Appeals on August 14, 2014. 3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




