## ORDER

---

In a motion to reinstate filed May 27, 2014, Appellants notified the Court they were continuing to negotiate with Respondents and had "in essence" reached a settlement agreement. Appellants noted, however, that settlement documents had not yet been executed, and they requested their case be reinstated to preserve the appeal should the settlement fail. In anticipation of the pending settlement, the Court will postpone remitting this case until August 25, 2014, which is 90 days from the date Appellants filed their motion. The parties shall promptly notify the Court if the circuit court approves or rejects the settlement, or if settlement negotiations break down. The Court may send the remittitur upon approval of the settlement or on August 25, 2014, unless good cause is shown why this case should not be remitted.
