This is to acknowledge that on September 14, 2014 I received your transcript request for the above-mentioned proceeding. I have reviewed my records and estimate that the transcript invoice will be approximately \$53.80, which includes shipping. The State charges an additional \$35 for emailed transcripts if you also require a pdf file.

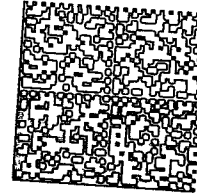
