


Dear Ms. Bakis-Ray,

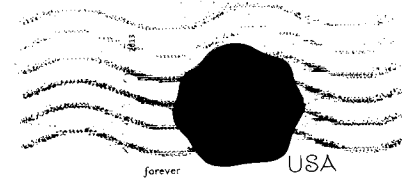
