**RE: Morrow v. SCDEW, Appellate Case 2012-207406**

Ms. Kitchings,

I hope this email finds you doing well.

On June 26, 2014, the Court of Appeals issued an order in the above-referenced case, accepting the settlement of the parties and agreeing to dismiss the appeal and vacate the published opinion. This Order was not a published Order, though, so it is not reflected on Westlaw. The June 26<sup>th</sup> Order gave DEW 90 days to submit "proof of payment of the settlement," and the Order stated that the remittitur would be held until proof of payment was submitted.

DEW filed a letter dated July 15, 2014, with an attached affidavit, indicating that all unemployment insurance payments had been made to Ms. Morrow. The online SC Appellate Case Management System does not reflect this letter/filing.

I am following up on this matter because we haven't received a response from the Court of Appeals and no remittitur has been sent. In addition, I believe any remittitur Order should be **published** to effectuate the Court's decision to **vacate** the published opinion issued on May 28, 2014.

I have attached to this email the Court of Appeals' Order from June 26, 2014, as well as the letter filed by DEW with the Court on July 15, 2014.
