**PETITION FOR EXTENSION TO FILE
PETITION FOR WRIT OF CERTIORARI
AND APPENDIX**

The undersigned counsel would respectfully request a **final** thirty-day extension, until **October 29, 2014** in which to file the petition for writ of certiorari and appendix in the above-referenced case. Arnold in the Court of Appeals on September 2, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Albert Santanio Kelly v. State in this Court on August 29, 2014. Counsel participated in a reconstruction hearing on August 28, 2014 before the Honorable L. Casey Manning in the case of State v. Michael Hockaday. Counsel filed the initial brief of appellant and designation of matter in the case of State v. James Simmons, Jr. in the Court of Appeals on August 20, 2014. 

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


