Consent Motion to Remand


Pursuant to Rules 240 and 261, SCACR, the parties in the above-captioned appeal, by and through their undersigned counsel, submit the within Consent Motion to Remand for the Court's consideration and approval. In support thereof, the parties would respectfully show unto the Court as follows:

1. Sensor Enterprises, Inc. ("Sensor"), J-Ray, Inc. ("J-Ray"), Palmetto Utilities, Inc. ("PUI"), and the South Carolina Office of Regulatory Staff ("ORS") are the only parties to this appeal and were the only parties of record below.
2. The parties respectfully request that this case be remanded (without prejudice) to the Public Service Commission so that the Commission may conduct a hearing on the parties' September 30, 2014, settlement agreement ("Settlement Agreement"), which is to be submitted to the Commission if the within motion is granted.

3. Should the Commission not approve the Settlement Agreement after hearing, this appeal may be reinstated before the Court. Such reinstatement will occur upon the filing of a notice of appeal by Sensor and J-Ray within thirty (30) days of its receipt of a Commission order rejecting the Settlement Agreement.
4. No party shall be taxed costs in this appeal




