
Dear Mr. Carmichael Flowers,

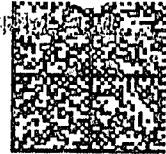

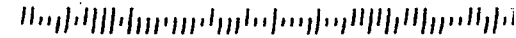


