The problem is Appellant doe snot know at this point if he made this correction of the references / if they are correct then it would be proper to exnor the correction of adding two, to each given reference above number 34.



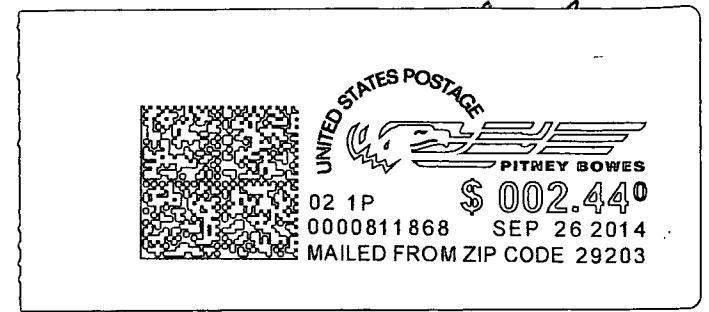
