
MOTION FOR EXTENSION OF TIME TO FILE INITIAL BRIEF OF APPELLANT AND  
DESIGNATION OF MATTER

This Motion of Appellant seeks an Order of this Court extending the time to file the Initial Brief of Appellant and Designation of Matter in the above-captioned appeal. Appellant seeks a four-day extension of time, until October 3, 2014, in which to file and serve these items. The ground for this Motion is that counsel's workload has prevented preparation of this document within the time frame required.

Appellant previously requested by letter a 30-day extension of time in which to file and serve the Initial Brief of Appellants and Designation of Matter, which would have set the




