


**STIPULATION OF DISMISSAL AS TO RESPONDENTS LEIGH MCKENZIE, M.D.

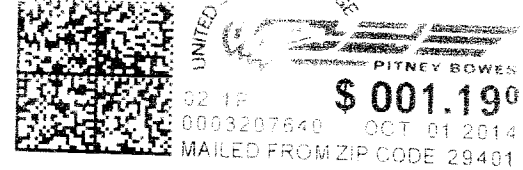
