
I am requesting an extension to file the initial Appellant's Initial Brief to the 10th day of October, 2014. I am enclosing a filing fee of \$25.00.

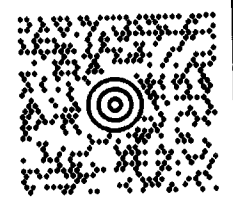

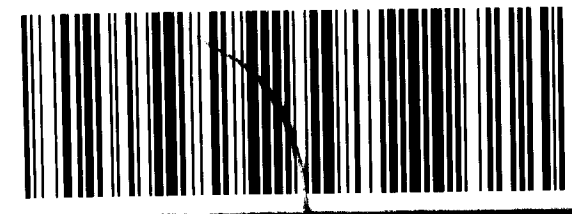
