
CONSENT TO REMAND APPEAL

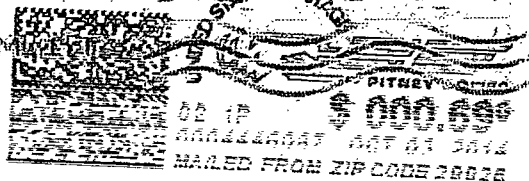
