
**APPELLANT'S DESIGNATION OF MATTER TO BE

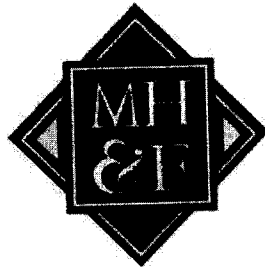
