

This matter comes before the Court pursuant to an application for post-conviction relief (PCR) filed July 15, 2010. The State made its Return and Motion to Dismiss requesting that the Application be summarily dismissed. Pursuant to this request, and after reviewing the pleadings in this matter and all of the records attached thereto, this Court issued a Conditional Order of Dismissal on August 5, 2013, and filed on August 15, 2013, provisionally denying and dismissing this action, while giving the Applicant twenty (20) days from the date of service of said Order in which to show why the dismissal should not become final. A copy of the signed Conditional Order of Dismissal was personally served on Applicant on August 27, 2013. The affidavit of service of process is attached and herein incorporated to this Final Order.

Applicant made no response to the Conditional Order of Dismissal within the twenty (20) day response period. This Court has reviewed the original pleadings and finds that a sufficient reason has not been shown why the Conditional Order of Dismissal should not become final.

IT IS THEREFORE ORDERED that, for the reasons set forth in the Court's Conditional Order of Dismissal, the Application for PCR is hereby denied and dismissed with prejudice.

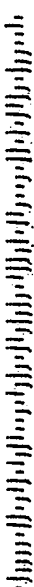
