

Thomas J. Quinn, counsel for Norman Quinton Hunt, Appellant, hereby moves for an extension of thirty (30) days to file the initial brief.

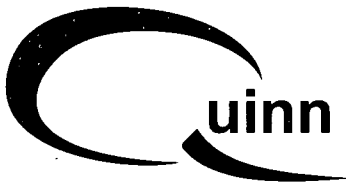

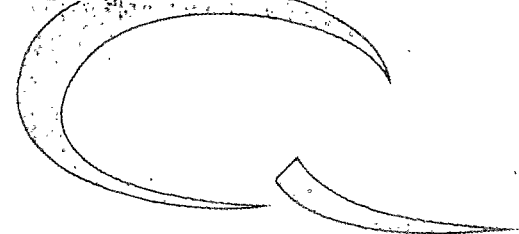

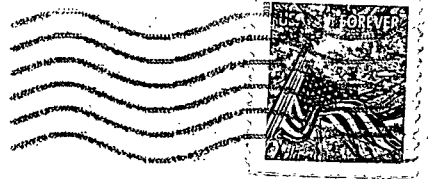
