MOTION FOR COSTS

Pursuant to Rule 222, SCACR, Vicki L. Wilkinson requests that the costs of this appeal be taxed against East Cooper Community Hospital, Inc. d/b/a East Cooper Regional Medical Center, Carolina Aesthetic Plastic Surgery Institute, PA, and Thomas X. Hahm, M.D., who were the Respondents. The Court reversed the circuit court's decision in an opinion filed July 23, 2014. The Court issued the remittitur in the case October 3, 2014.

Rule 222(a) provides that when a judgement is reversed, costs shall be taxed against the respondent unless the court orders otherwise. Because the Court has not ordered otherwise and the parties have not agreed otherwise, the rule provides the Court

should award costs to Appellant.
