MOTION TO SUBSTITUTE CO-COUNSEL FOR PETITIONER

arising from this change in law firms, Mark S. Sharpe requests to be relieved as counsel of record for Petitioner in this matter.


2. Petitioner will not be prejudiced by the relief requests because (i) existing co-counsel to Petitioner—Edward P. Guerard, Jr.—will continue to serve in that capacity, insuring continuity in the representation, and because (ii) T. Alexander Beard will be substituted as co-counsel.

4. Existing co-counsel of record for Petitioner, Edward P. Guerard, Jr., will continue as co-counsel of record for Petitioner.


